# 2011 EXTREME TEAM AGREEMENT

Athlete agrees to the following:

1. Athlete is highly encouraged, but not required, to wear an Endurance Multisport uniform, shirt, or other Endurance Multisport-logoed apparel during competition, during training sessions, and while attending award ceremonies, whether accepting an award or not.
2. Athlete will promote Endurance Multisport whenever possible to fellow athletes, businesses, and within your community.
3. Athlete will not defame or disparage Endurance Multisport. Athlete will also agree to use reasonable care to avoid injury to people or damage to property in the course of your participation in any event or activity supported or sponsored by Endurance Multisport. Athlete also agrees to conduct him/herself in a professional manner while representing Endurance Multisport. If these terms are violated, athlete agrees to indemnify and hold Endurance Multisport harmless from any resulting claims made against Endurance Multisport. Endurance Multisport may, at its option and without delay, terminate this agreement for any reason or for no reason anytime after the date such act or conduct on the part of the athlete becomes known.

In consideration of Athlete's engagement as a model and/or athlete, Athlete hereby gives Endurance Multisport L.L.C. the absolute right and permission to: 1) display publicly Athlete's submitted photo(s) and full, partial, or edited responses to Extreme Team application profile questions on any or all website domains owned by Endurance Multisport; and 2) to copyright and use photographs of him/her or in which he/she may be included in conjunction with his/her own or fictitious name for the purpose of advertising.
5. Athlete warrants that he/she is of legal age and has every right to contract in his/her own name in the above regard. He/she has read the above consent and release, prior to its execution, and is fully familiar with and agrees to the contents thereof.
